It is the responsibility of Luna's House, Inc., to offer for adoption healthy, socialized animals to the extent possible, and it is the responsibility of foster care providers to care for foster animals in a manner consistent with this responsibility.

I certify that my own pets are up to date on their Rabies vaccinations, where appropriate.

I agree to the following conditions:

I will keep my foster animals in a cage or terrarium separate from those of my own animals. I understand that there is a risk of my pets becoming ill from exposure to foster animals.

I will provide only approved bedding or litter (CareFresh or an approved derivation thereof or unscented aspen for bedding, CareFresh or an approved derivation thereof, wood stove pellets, Feline Pine or an approved derivation thereof, or Yesterday's News for litter) and approved food as advised by the appropriate adoption coordinator.

I will provide fruits, vegetables, and hay where necessary and in the amounts and types advised by the appropriate adoption coordinator.

I will handle and/or interact with my foster animal daily in a safe and appropriate manner.

I will monitor my foster animal(s) regularly, conduct regular health checks, and immediately notify the appropriate adoption coordinator of any concerns about a foster animal's health or behavior.

If my foster animal requires veterinary attention, then I will do my best to obtain permission from the appropriate adoption coordinator before taking the animal to the veterinarian. If I take my foster animal(s) to the veterinarian without prior approval, then I understand I may be responsible for the bill.

If I take my foster animal(s) to the veterinarian, I will discuss any suggested veterinary procedures, including but not limited to diagnostics such as bloodwork or radiographs, non-routine procedures, or euthanasia, with the appropriate adoption coordinator before they are undertaken.

The foster animals are the responsibility of Luna's House, Inc. I will adhere to any decisions by Luna's House, Inc., about the return or placement of the foster animal(s).

I must make prior arrangements to return my foster animal(s) to Luna's House, Inc.

I may not take in animals on behalf of Luna's House, Inc., from individuals, animal shelters, or any other sources, without prior permission of Luna's House, Inc.

Foster animals must be adopted through Luna's House, Inc., and they may not be released into the care of anyone prior to the completion of the full adoption process.

An authorized agent of Luna's House, Inc., may check on any foster animals in my care and remove them if deemed necessary.

Luna's House, Inc., and its authorized agents are not responsible for any accidents, injuries, or illnesses arising from the fostering of LHI animals.

I will follow all foster care policies and procedures.
